The 10 question screening questionnaire asks contractors about how they are meeting their contractual obligations.	
Pharmacy Collect	Advanced Service	Weekly	Data needs to be recorded on MYS on the last trading day of the week. This data will populate the payment claim at the end of the month. More information <a href="here">here</a> Service currently commissioned until 29 <sup>th</sup> August 2021.	
Pandemic Delivery Service – self isolating	Advanced Service	30 <sup>th</sup> Sept	SERVICE EXTENDED  The Delivery Service continues for those patients that need to self isolate. Patients will need to provide their Track & Trace ID reference number as proof of eligibility. More information <a href="https://example.com/here">here</a>	
Covid costs claiming	Pharmacy Income	15 <sup>th</sup> August	Claim between 5 <sup>th</sup> July and 15 <sup>th</sup> August for costs incurred March 2020 – March 2021. To be paid in October 2021.  More information <u>here</u>	
Mandatory health campaign	Contractual	Now	Covid vaccination campaign – 'Join the Millions' To encourage uptake of the vaccination. A campaign pack should have arrived at pharmacy.  This campaign is for a minimum of 2 months. More information here
