Isosorbide mononitrate (Monomil® XL) 60mg modified-release tablets

## Summary

- Isosorbide mononitrate (Monomil® XL) 60mg modified-release tablets are out of stock until the end of June 2024.
- Chemydur<sup>®</sup> 60XL, Isotard<sup>®</sup> 60XL, Relosorb<sup>®</sup> XL 60mg, Monomax<sup>®</sup> XL 60mg, Monosorb<sup>®</sup> XL 60 and Tardisc<sup>®</sup> XL 60 tablets remain available and can all partially support the increased demand.
- Other brands of isosorbide mononitrate 60mg modified release-tablets are available but are not able to support the increase in demand.
- A Serious Shortage Protocol (SSP) was issued on 26/03/2024.

#### **Actions Required**

Remaining isosorbide mononitrate (Monomil® XL) 60mg modified-release tablets should be reserved for patients identified as needing to be maintained on that brand.

Where a prescription for isosorbide mononitrate (Monomil® XL) 60mg modified-release tablets is presented and cannot be fulfilled, community pharmacists should:

• supply an alternative isosorbide mononitrate 60mg modified release-tablet preparation according to the products specified in SSP059.

If the patient is deemed ineligible or does not consent to receive an alternative product via the SSP, clinicians can consider prescribing the following products:

- Chemydur<sup>®</sup> 60XL, Isotard<sup>®</sup> 60XL, Relosorb<sup>®</sup> XL, Monomax<sup>®</sup> XL, Monosorb<sup>®</sup> XL 60 and Tardisc<sup>®</sup> XL 60 tablets; or
- a suitable alternative medicine.

## Supporting information

Patient reassurance may be needed when switching between isosorbide mononitrate formulations.
