# 6. LES for BH 26<sup>th</sup> August 2024

Southeast Pharmacy Commissioning Hub are currently reviewing the pharmaceutical provision on August Bank Holiday (Monday 26 August 2024) on behalf of all Integrated Care Boards (ICB)s across the Southeast Region. They have identified the areas (listed below) where there is insufficient pharmaceutical provision and are looking to fill these gaps with pharmacies who volunteers to open under a Local Enhanced Service (LES) agreement.

The LES agreement would be as follows:

- **1.** To open for a three-hour period between 10:00-13:00 or 14:00-17:00, final time slot to be agreed with the Southeast Pharmacy Commissioning Hub
- **2.** Payment will be: £**300 per hour** (£900 for the total three-hour session)

# 7. Changes to how pharmacist can contact Healthcare Professional number to follow up on referral from 111 for pharmacies in HIOW:

A regional Interactive Voice Response (IVR) will shortly be switched on for NHS 111 - this change will affect the way healthcare professionals' access 111 on behalf of a patient (e.g. when a patient is referred by NHS 111 for Pharmacy First and needs to be referred back to 111 for e.g. a minor illness which needs escalating or request for a CD). SCAS have have always provided dedicate Health Care professional lines, these dedicated lines will remain in place for the immediate future alongside the new regional 111 Interactive voice response IVR option which has a Health care professional option.
