# Children aged 2 or 3 years\* influenza vaccination offer from Community Pharmacies

To help support improvements in access and uptake, community pharmacies will be able to offer children aged 2 or 3 years flu vaccinations during the 2025 to 2026 flu season.

Community pharmacy service delivery will begin from 1 October 2025.

Details are set out in the [Amendment to the national flu immunisation programme 2025 to 2026 letter](#).

The requirements for the service are set out in the [service specification](#) and alongside this a separate patient group direction for community pharmacies to cover both the live attenuated influenza vaccine (LAIV) and the cell-cultured inactivated influenza vaccine (IIVc) administration to this age group will be published.

- the first line flu vaccine choice for children is the LAIV as this is the most clinically effective vaccine to administer to this age group. IIVc is recommended where LAIV is contraindicated or otherwise unsuitable (for example, parents object to LAIV on the grounds of its porcine gelatine content).
