1. INFORMATION: August Bank Holiday Posters

2. INFORMATION: Funded Accuracy Checking Pharmacy Technician (ACPT) Programme

CPPE are now open for applications for the funded ACPT programme. Applications will close when all 240 places have been allocated or at the end of March 2026. The Clinical Audit has been published. It must not be started before 1st September. You need to record a minimum of 10 sore throat consultations over 4 weeks. 5. INFORMATION: HRT Pre Payment Certificates (PPC)
