## **Quality Payments review date**


Tomorrow (Friday 29th June 2018) is the June review point for the interim Quality Payments Scheme. Community pharmacy contractors are reminded to make use of the following tools to check whether their pharmacy is meeting the related criteria.

## **Disclosing pricing information**

From 1st July 2018, the Department of Health and Social Care (DHSC) will have greater powers to request information about the prices and costs associated with products purchased for the NHS in England.
